1. Tested with a standard test nozzle with diameter of 12,5 mm;
2. The delivery rate: 100 L/min;
3. Core of substantial stream: circle of approximately 120 mm diameter at 2,5 m distance from nozzle;
4. Test duration: 3 min;
5. Distance from nozzle to enclosure surface: 2,5 m.

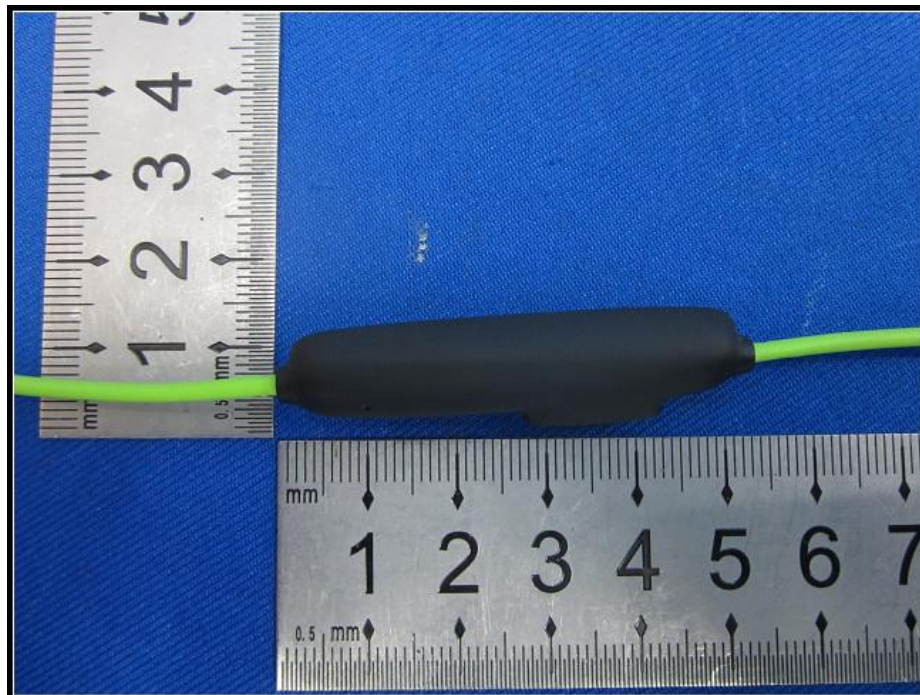

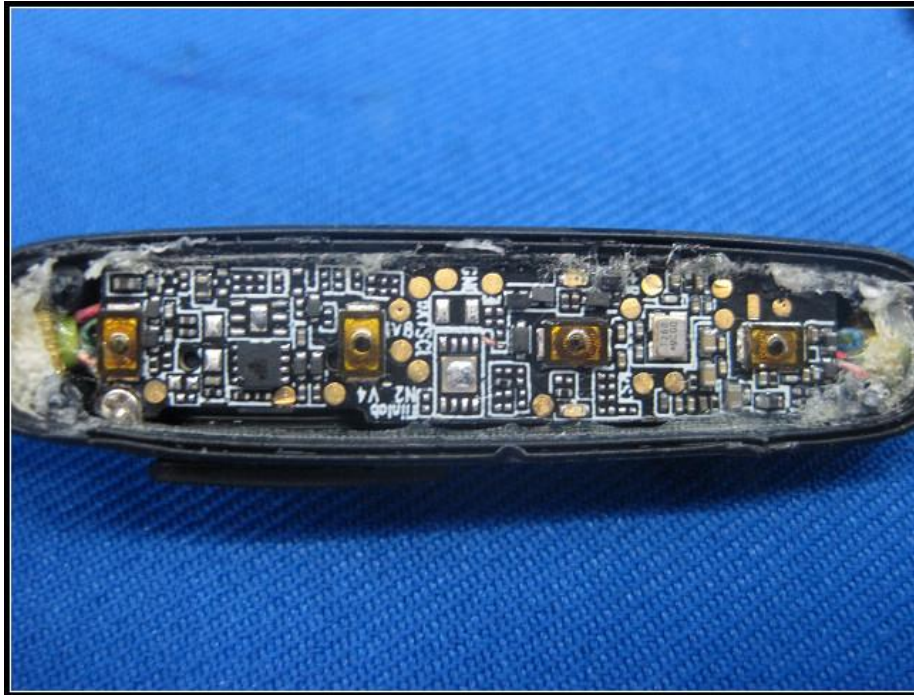
