



DROPSHIPPING

The »Dropshipping« service is available to you via our **webshop**.

The following conditions must be met:

- Only possible for webshop orders.
- Deliveries to EU-Member states (tax free deliveries within Germany are not possible).
- The delivery address must be entered by you in the webshop (see point »How do I set the delivery address?« on page 2/2).
- If your delivery note is to be enclosed, it must be sent to us promptly as a PDF file. If you want permanent shipping in your name, we can deposit your delivery note in our system.

- Flexible location

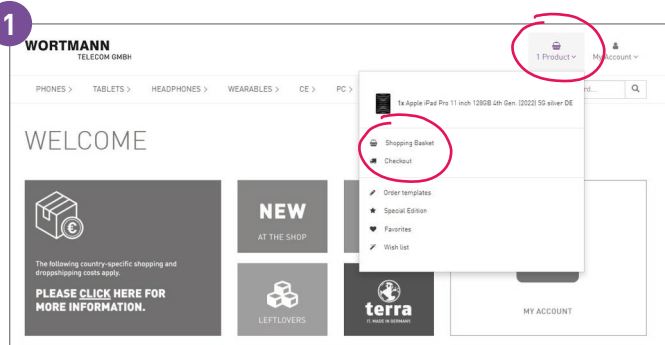
Dropshipping abroad:

- No freight free limit when shipping abroad

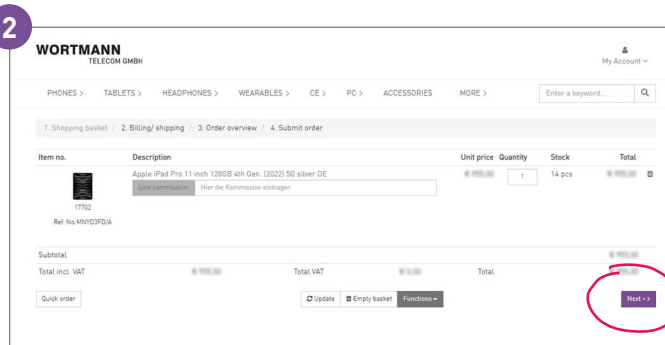

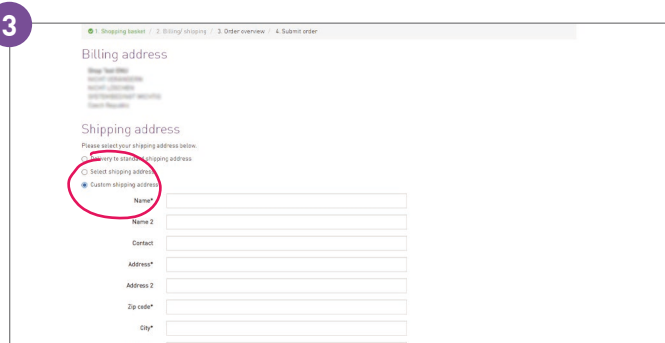
How do I set the delivery address?



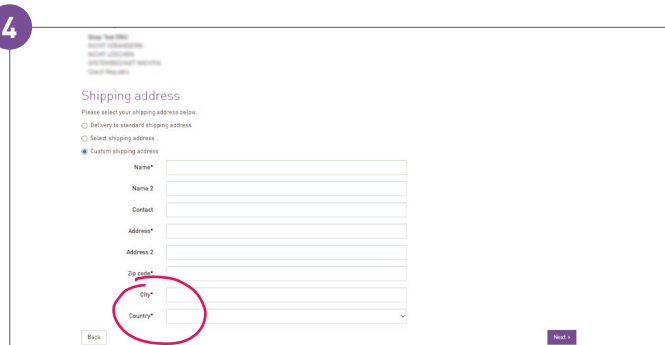
Start the ordering process: click on the shopping basket and then select »**Shopping Basket**« or »**Checkout**« from the drop-down menu.



First, check your order in step 1 of the ordering process. If everything is correct, click on »**Next**«.



In step 2 of the ordering process (»2. Billing/Shipping«), select »**Custom shipping address**« under Shipping address.



Now fill out the form. Please note that the country must be a member of the EU. Then continue with the ordering process.

What else is there to know?

Shipping by UPS

- UPS does not deposit any messages with the end customer but delivers again. UPS may make up to three delivery attempts at its discretion at your address on regular UPS delivery days. If you're unavailable when UPS attempts delivery at your address, UPS may deliver your parcel to a UPS Access Point® location near your home, where your parcel will be held for you to collect for 7 calendar days. After 7 calendar days, your parcel will be returned to the sender as undeliverable. These costs are passed on to the trading partner.
- Additional costs for separate destinations, extenden area surcharge, corrections, address changes or refusals are going to be passed to the trading partner.
- The contract is concluded between the (commercial) end customer and the trading partner, service processing and returns are only handled by the trading partner, not by us.

We have taken note of the information and conditions provided and agree to the resulting costs.
